Student Protection Policy (7th - 12th grade)

1. Convictions for sexual abuse, physical abuse, or other crimes pertaining to the safety of students will exclude an adult from participating in the student ministry of Community Church.
2. Adult volunteers may not at any time, (even outside of programs, or off site) be alone with a student of the opposite sex (this includes giving students rides, etc.).
3. Adult volunteers are required to immediately report to the student ministry staff, any behavior that could be considered illegal, sexually inappropriate, abusive, or endangering to students in any way.
